Shakespeare Auteur: Creating Authentic Characters for the Screen (recorded)

## 11:05 am **Professor Sky Gilbert, Ph.D.**

Shakespeare Beyond Science: When Poetry Was the World (recorded)

This lecture explores how Edward de Vere, Earl of Oxford, writing as "Shake-speare," was not only at the center of a "euphuistic" Elizabethan literary circle, but was also steeped in the ancient Greek rhetorical tradition of Hermogenes.

11:25 am Steven Sabel (Symposium Master of Ceremonies) — The Mentors to Genius

Shakespeare is widely viewed as a "natural" genius, sometimes compared to Mozart or Einstein. This lecture explores how such geniuses are typically recognized at an early age by mentors who foster their education and development. The mentors of the author "Shakespeare" are easily found if we open our minds to the idea that he was not a glover's son from Stratford.

Lord Prospero in The Tempest and Lord Prospero Visconti

It has long been speculated that Prospero may represent, in part, the author "Shakespeare," a magus conjuring plays on his theatrical "island." Is he also based on an actual historical Duke of Milan who sought refuge in the arts? This lecture explores an excellent candidate, proposed by an art historian in 1950 whose insight has been ignored by orthodox scholars. Edward de Vere, Earl of Oxford, may well have met this Duke during his 1575–76 European tour.

Shakespeare in Stratford and London: Ten Eyewitnesses Who Saw Nothing

Orthodox scholars insist that a businessman from Stratford was the author "Shakespeare." But this lecture explores ten people who personally knew or met the Stratford man or his daughter Susanna. They left numerous writings, some referring directly to people and events in Stratford. Most and possibly all were aware of the "Shakespeare" plays and poems. Yet none of these eyewitnesses left any hint that they connected the Stratford man with those literary works.

2:40 pm Professor Bryan H. Wildenthal, J.D.

Early Authorship Doubts: The Oxfordian Connections (recorded)

This lecture explores some of the dozens of early published doubts about the authorship of the Shakespearean works — doubts forming an integral part of Shakespeare's own time and culture. Many suggest the author was an aristocrat. Some point specifically to Edward de Vere, Earl of Oxford.

3:20 pm **Donald Ostrowski, Ph.D., Lecturer in History, Harvard University Extension School** — Toward an Epistemology of Attribution: A Comparison of the Shakespeare and Kurbskii Authorship Controversies (recorded)

This lecture is drawn from Dr. Ostrowski's new book, *Who Wrote That?* Authorship Controversies from Moses to Sholokhov. Dr. Ostrowski, who finds the Oxfordian theory of Shakespeare authorship convincing, explores twelve points of comparison between that controversy and the dispute over works attributed to Russian Prince Andrei Kurbskii (d. 1583). He evaluates the two controversies and shows how they advance the overall scholarly study of literary attribution.

Short biographies of the principal symposium speakers, the two main symposium hosts, and the master of ceremonies are on the following two pages in alphabetical order.



Mark André Alexander earned a B.A. in English and M.A. in Organization and Management Development. He has taught legal writing and worked in Silicon Valley training engineering managers in Cognitive Science and High Performance Thinking. He is the author of several books and a landmark 2001 article in *The Oxfordian:* "Shakespeare's Knowledge of Law." His Shakespeare authorship website (<a href="https://sourcetext.com/sourcebook">https://sourcetext.com/sourcebook</a>) is a remarkable resource for examining numerous relevant texts.



Ben August, Symposium Host and SOF Trustee, is a vintner in Napa County, California, whose Cabernet and Merlot wines are marketed under his "Earl 17" label. Upon embracing the Oxfordian theory, he resolved to remove the traditional Stratfordian Shakespeare bust from his library. He commissioned a bronze bust of Edward de Vere, Earl of Oxford, by sculptor Paula Slater. An original has been placed at Castle Hedingham in England. In order to keep de Vere's personal copy of a book by Herodotus in Oxfordian hands, Ben purchased it at auction last year.



Katherine Chiljan earned a B.A. in History at UCLA and has published two edited volumes of poems and letters by, and dedication letters to, Edward de Vere, Earl of Oxford. She is the author of *Shakespeare Suppressed: The Uncensored Truth About Shakespeare and His Works* (2011, rev. 2016), which earned her an award for distinguished scholarship at Concordia University in Oregon. She has debated and lectured frequently on the Shakespeare authorship question, including in a 2003 debate at the Smithsonian Institution.



Cheryl Eagan-Donovan, honored as Oxfordian of the Year in 2019, is a Boston-based film director, writer, and producer. She earned her M.F.A. in Creative Writing at Lesley University. Her newest documentary, *Nothing Is Truer Than Truth*, premiered at the Independent Film Festival Boston in 2018, and is on disk, Amazon Prime, and Hulu. She has published several articles on screenwriting and film, and teaches writing, film, and literature at Lesley University and Northeastern University.



**Sky Gilbert**, Ph.D., is Professor of Creative Writing and Theatre at the University of Guelph, Ontario. He is a prolific and award-winning poet, novelist, playwright, and director. He was co-founder and longtime artistic director of Buddies in Bad Times Theatre in Toronto, one of the largest gay and lesbian theatres in the world. His lecture is based on his new book, *Shakespeare Beyond Science: When Poetry Was the World* (2020).



John Hamill, Symposium Host, served as the first President of the SOF in 2013–14, after playing a major role in unifying its predecessor organizations. He was again elected SOF President in 2018. He studied at the University of Puerto Rico, California State University, and the University of California, and holds a Master's degree in Historical Geography. He lives in San Francisco and is a retired project manager for the U.S. Environmental Protection Agency. He has published several scholarly Shakespearean articles and is an expert on Shakespeare's sexuality.



Ramon Jiménez, co-recipient of the 2018 Oxfordian of the Year Award, is the author of two acclaimed book club selections on the history of ancient Rome: Caesar Against the Celts and Caesar Against Rome. His most recent book, Shakespeare's Apprenticeship (2018), demonstrates that several anonymous plays were early versions of canonical Shakespearean works, most likely written by Edward de Vere, Earl of Oxford.



**Donald Ostrowski**, Ph.D., is Lecturer in History and Research Advisor in the Social Sciences at Harvard University's Extension School, and a recipient of the Early Slavic Studies Association Award for Distinguished Scholarship. He is the author of several books, including *Muscovy and the Mongols* (Cambridge Univ. Press, 1998), and more than 150 publications altogether. His most recent book is *Who Wrote That? Authorship Controversies from Moses to Sholokhov* (2020).



Steven Sabel, Symposium Master of Ceremonies, is the former Producing Artistic Director of the Archway Theatre Company in Burbank, and founder and Producing Artistic Director of the Redlands Shakespeare Festival, both in California. He is an actor and director whose many diverse theatrical productions include 60 stagings of 23 Shakespearean works. He now lives in Oregon, serving as Director of Public Relations for the City of Grants Pass, and in the same role for the SOF. He hosts the SOF "Don't Quill the Messenger" podcast series.



Earl Showerman, M.D., graduated from Harvard College and the University of Michigan Medical School. He practiced emergency medicine for more than 30 years in Oregon, where he is a longtime patron of the Oregon Shakespeare Festival. After retiring from medicine, he studied Shakespeare at Southern Oregon University and now lectures and publishes prolifically on Shakespeare's knowledge of medicine and ancient Greek dramatic sources. He is a Trustee of the SOF and past President of the Shakespeare Fellowship.



James A. Warren served as a U.S. Foreign Service officer for many years, and as executive director of the Association for Diplomatic Studies and Training. He is the editor or author of several books, including the modern scholarly edition of J. Thomas Looney's "Shakespeare" Identified (1920) and "Shakespeare" Revealed: The Collected Articles and Published Letters of J. Thomas Looney (2019). He is currently working on a major new study of Looney's life, work, and influence.



Bryan H. Wildenthal, Professor of Law Emeritus, earned his A.B. and J.D. at Stanford University. He is scheduled to teach as a Visiting Professor at the University of San Diego School of Law in the spring of 2021. He is the author of a law textbook and many articles in leading law reviews, including one cited by the U.S. Supreme Court in 2010 and 2019. His most recent book is *Early Shakespeare Authorship Doubts* (2019). He recently served as First Vice-President of the SOF, and serves currently as the SOF Website Content Editor.

## About the Shakespeare Oxford Fellowship

Founded in 1957 and based in the United States, we have members around the world and work in concert with the De Vere Society (DVS) based in the U.K. We encourage our members to join the DVS as well.

The SOF sponsors annual scholarly conferences and publishes an annual peer-reviewed scholarly journal, *The Oxfordian* (founded in 1998), and the quarterly *Shakespeare Oxford Newsletter* (now in its 56th volume). The SOF, then known as the Shakespeare Oxford Society, merged in 2013 with a related organization, the Shakespeare Fellowship, which published another annual scholarly journal, *Brief Chronicles* (2009–16), which now continues as a series of occasional scholarly books. The SOF sponsors original research on Shakespeare authorship through its Research Grant Program.

The SOF website provides a wealth of news and information, including free access to back issues of our journals as well as many more historical authorship publications, many original new articles, and a YouTube channel with fascinating lectures that have amassed more than 300,000 views.
